RULES AND REGULATIONS

1. Contestant must be a resident within a Fifty-Mile radius of Warren County, Virginia. Proof of residency may be requested at any time.
2. Contestant ages are Newborn – 11 months, 1 Year Old, 2 Years Old, 3 Years Old or 4 Years Old (Male and Female Divisions). Division determined by age on July 24, 2010.
3. Contestant will be judged in Sunday Best. ****NO PAGEANT WEAR**** Contestant will be scored on beauty, personality, selection of attire and overall appearance.
4. Only one person may be backstage with contestant at all times.
5. Registration will be available starting June 8, 2010. An application, rules and regulations will be available via the Internet and available at the Warren County Fair Office. Applications can be mailed to P.O. Box 1555, Front Royal, VA 22630 or turned into the Fair Office in person.
6. A **non-refundable** registration/sponsor fee of \$35.00 is required of each contestant. Sponsors may be parents, relatives, businesses, etc. The Deadline for registration is July 24, 2010 by 5:00pm. **Entry fee shall be paid by cash, money order or check and made payable to Warren County Fair.**
7. Practice will be held at the Warren County Fairgrounds (stage area) and is **mandatory**. A representative (parent, guardian, family friend etc.) must attend during time assigned for each age group. Each contestant must have a representative present to acquire stage format, time slots and any additional information. Rehearsal times are available during time of registration.

8. In order to provide a smoothly run pageant, all parents are asked to adhere to the rules. Time slots will be assigned at practice for each age group and it is important to **BE ON TIME**.
9. One parent will be admitted free with each contestant. Others must pay admittance fee at the gate.
10. Each winner will receive a crown or tiara, trophy and sash. Runner-ups will receive a trophy. All participants will receive a participation ribbon and gift.
11. Poor Sportsmanship will not be tolerated.

Dress for these categories will be "Sunday Best" ONLY! Please DO NOT put your children in "Pageant Wear", which includes dress w/glitz, crinolines, etc. "Dollywood" style dresses and Tuxedos are **not allowed**. Five points per judge will be deducted for pageant wear. This is done for the children's comfort and to lessen the parent's expense. Please abide by these rules. The judges will determine whether or not your child is wearing "Pageant Wear". Dress your child in an outfit that you would take them to church, family functions or outings in.
