RULES AND REGULATIONS

1. Contestant must be a resident of Warren County. Proof of residence may be requested at any time.
2. Contestant must be 22 years old by January 9, 2011.
3. Contestant must be of good moral character; never been convicted of a crime or have had any criminal charges pending against them. Contestants should not have engaged in any activities that are characterized as dishonest, immoral or indecent.
4. Contestant will be judged using a point system based on poise, speaking ability and overall appearance.
5. Contestant will participate in an evening gown competition. The Top Five will answer a spontaneous question.
6. Registration will be available starting June 8, 2010. An application, rules and regulations will be available via the Internet and available at the Warren County Fair Office. Applications must be mailed to P.O. Box 1555, Front Royal, VA 22630 or turned into the Fair Office. A **non-refundable** registration/sponsor fee of \$35.00 is required of each contestant. Sponsors may be relatives, businesses, etc. The Deadline for registration is July 24, 2010 by 5:00 p.m. **Entry fee shall be paid by cash, money order or check and made payable to Warren County Fair.**
7. Monday, July 26 at 6:00 p.m. practice will be held at the Warren County Fairgrounds in the stage area and is **mandatory**. NO EXCEPTIONS!
8. The winner will reign over the 2010 Warren County Fair and must be available for participation in any events required by the Directors and Fair Association. The winner will also be required to attend additional functions designated by the Fair Association, parades, participate with fundraisers and to crown the new 2011 Ms. / Mrs. Warren County.
9. In the event the first runner-up must reign as Ms. / Mrs. Warren County Fair, she will be expected to crown the new queen in the 2011 Ms. / Mrs. Warren County Fair Pageant and perform the duties while holding the title.
10. The Warren County Fair Association will approve the participation of the winner in any event as a representative of the Warren County Fair. Participation in other pageants is not permissible during the 2010 reign.
11. Contestant may compete in the pageant competition if they do not hold any other titles at the time of the pageant. Winner can compete in the same division twice; however, it must be one year since passing the crown to compete. Participants may be required to verify that they have never had a previous title relinquished.
12. Contestant will uphold moral standards of the Warren County Fair Association and at such time as said moral standards are breached, the title holder will relinquish her title, crown, and banner. At that time, the First Runner up will take over the title.
13. Poor Sportsmanship will not be tolerated.
